



## Features

- Built-in bias resistors enable the configuration of an inverter circuit without connecting external input resistors (see inner circuit).



## • Electrical characteristic curves (T<sub>a</sub> =25°C)






Fig.2 Output current vs. input voltage (OFF characteristics)




Fig.3 Output current vs. output voltage






Fig.4 DC current gain vs. output current



## •Electrical characteristic curves (T<sub>a</sub> =25°C)




## Fig.5 Output voltage vs. output current
