



Features

- 1) Built-In Biasing Resistors, $R_1 = 4.7k\Omega$, $R_2 = 10k\Omega$
- 2) Built-in bias resistors enable the configuration of an inverter circuit without connecting external input resistors (see inner circuit).
- 3) Only the on/off conditions need to be set for operation, making the circuit design easy.
- 4) Complementary NPN Types: DTC143XCA

Fig.1 Input voltage vs. output current (ON characteristics)




Fig.2 Output current vs. input voltage (OFF characteristics)




Fig.3 Output current vs. output voltage






Fig.4 DC current gain vs. output current




● Electrical characteristic curves (T_a =25°C)
