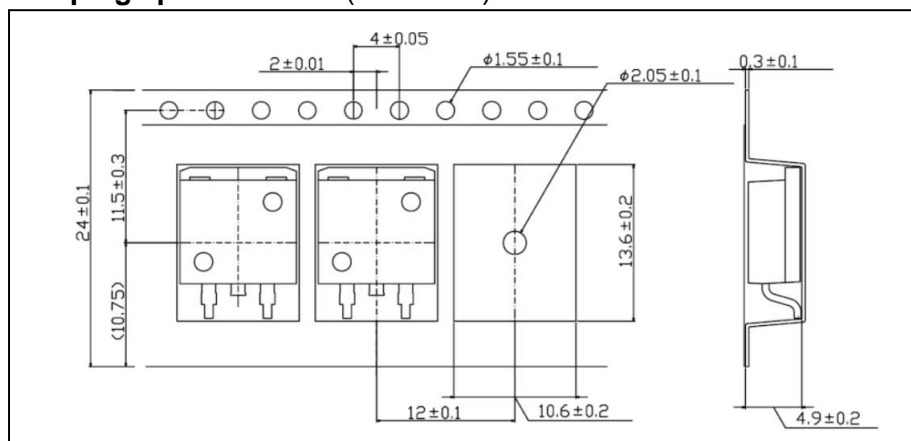

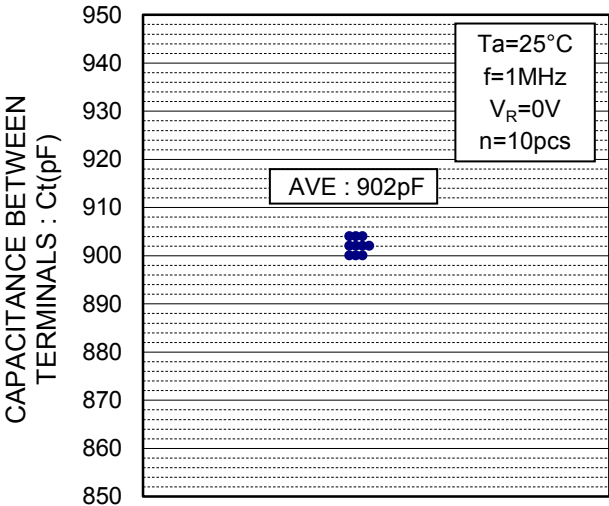
●Electrical characteristic curves



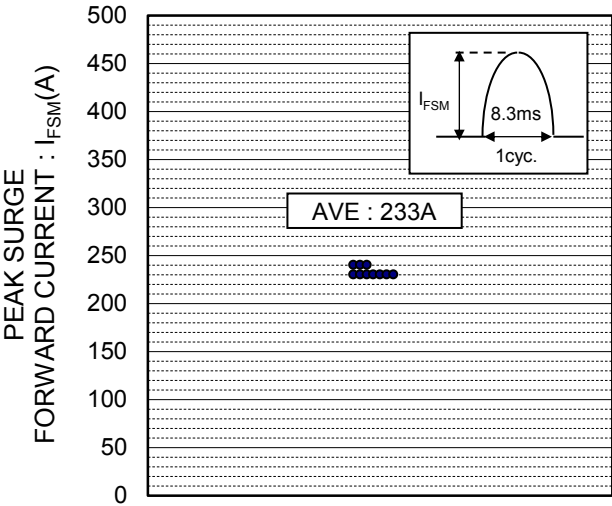

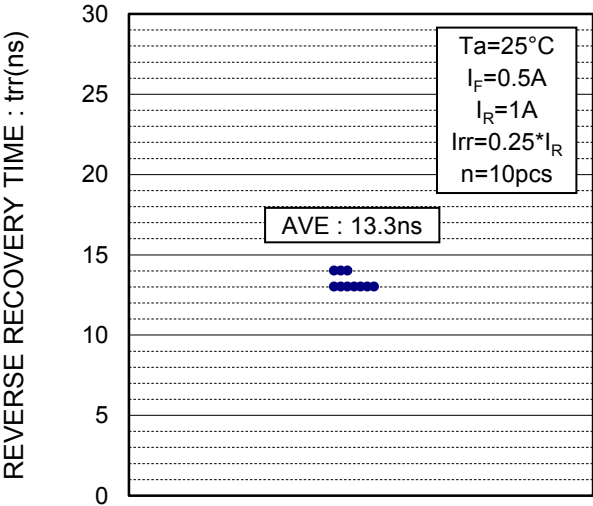
$I_R$  DISPERSION MAP



$C_t$  DISPERSION MAP

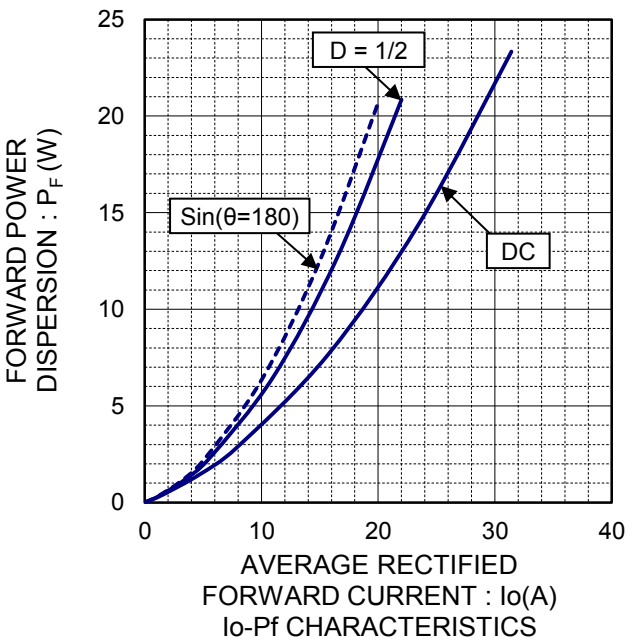
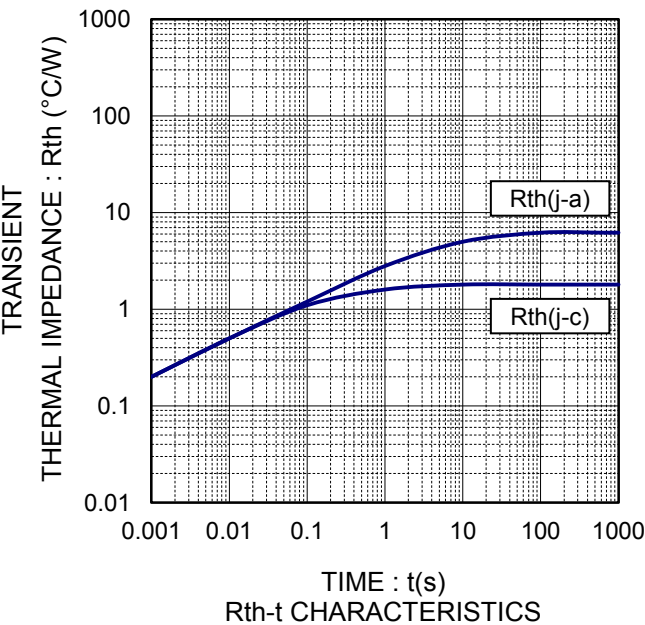
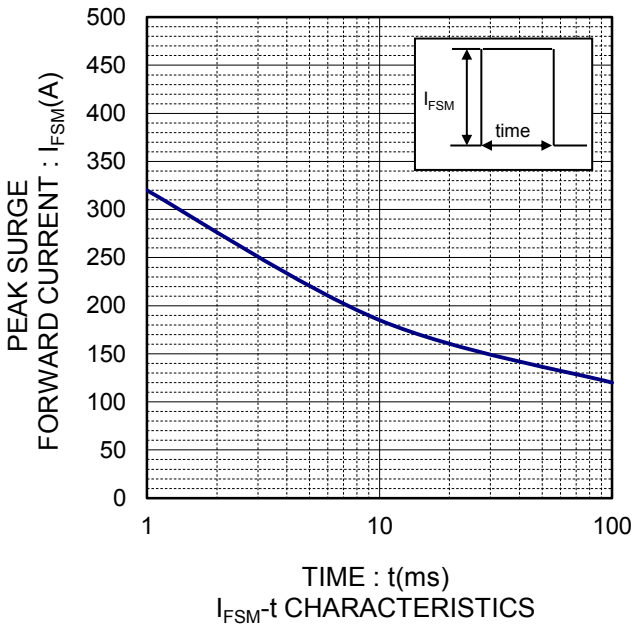
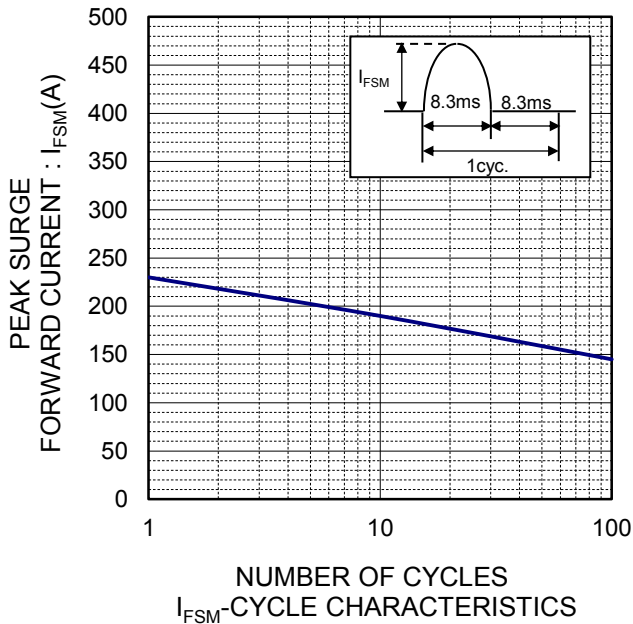


$I_{FSM}$  DISPERSION MAP

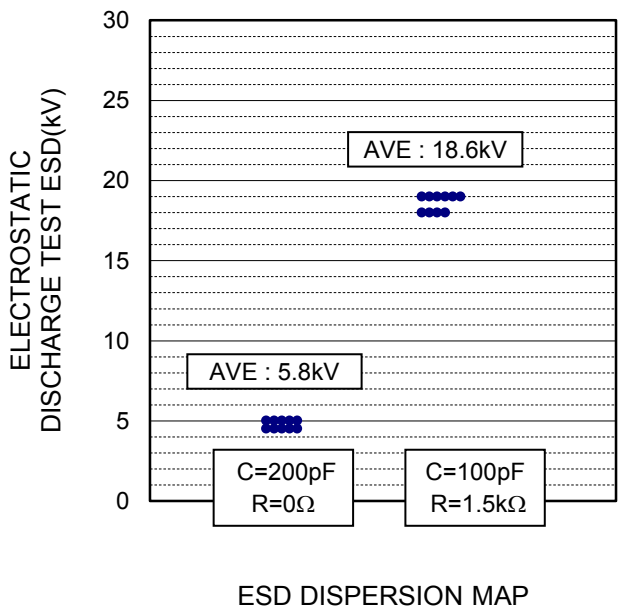
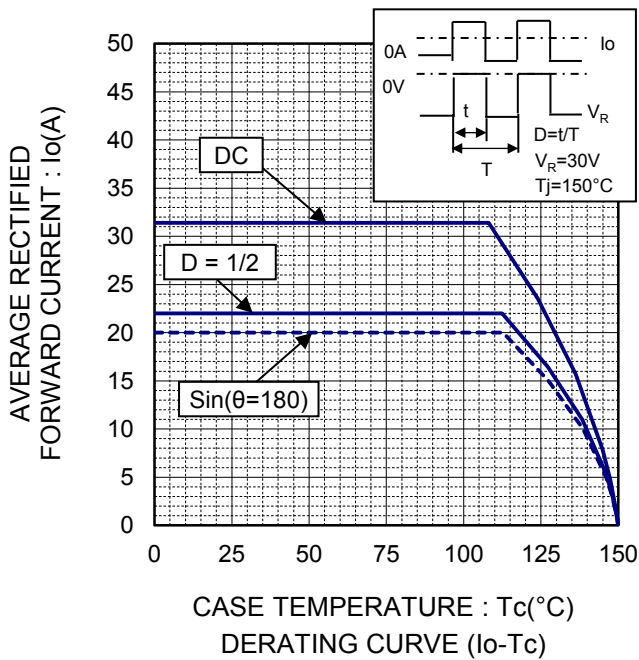
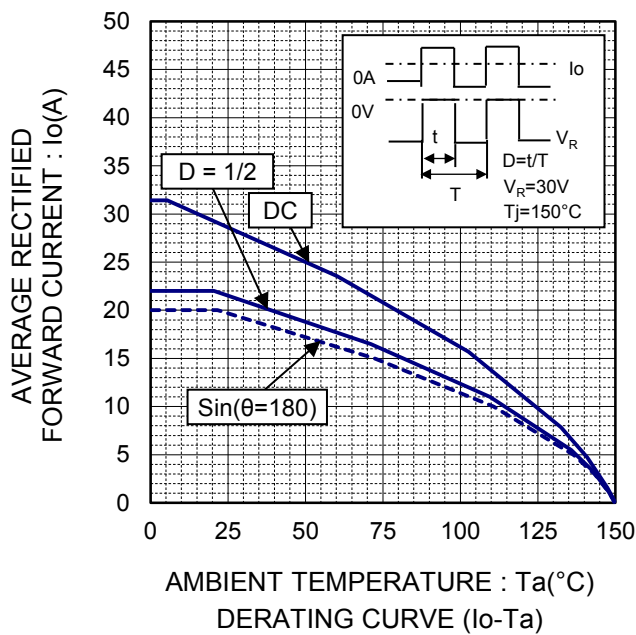
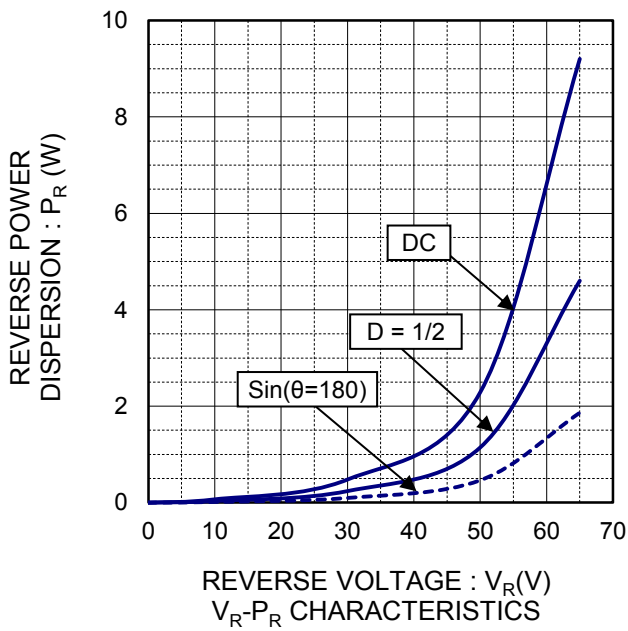
